Minutes of Meeting:

September 2020 strategic board meeting minutes presented.

<u>Motion</u> by 2^{nd} VP Chapman to accept minutes as presented, 2^{nd} by 1^{st} VP Stenhouse. Motion passed unanimously.

President's Report:

Keep moving forward and hope to be meeting in person as a board and as an association in the fall of 2021. President Sartain shared about the new OSFM new Fire Investigator Certification that has been rolled out. Oregon IAAI was not consulted as expected. President Sartain suggested that 1st VP Stenhouse reach out to see how we might incorporate some of this training in the upcoming training seminar.
